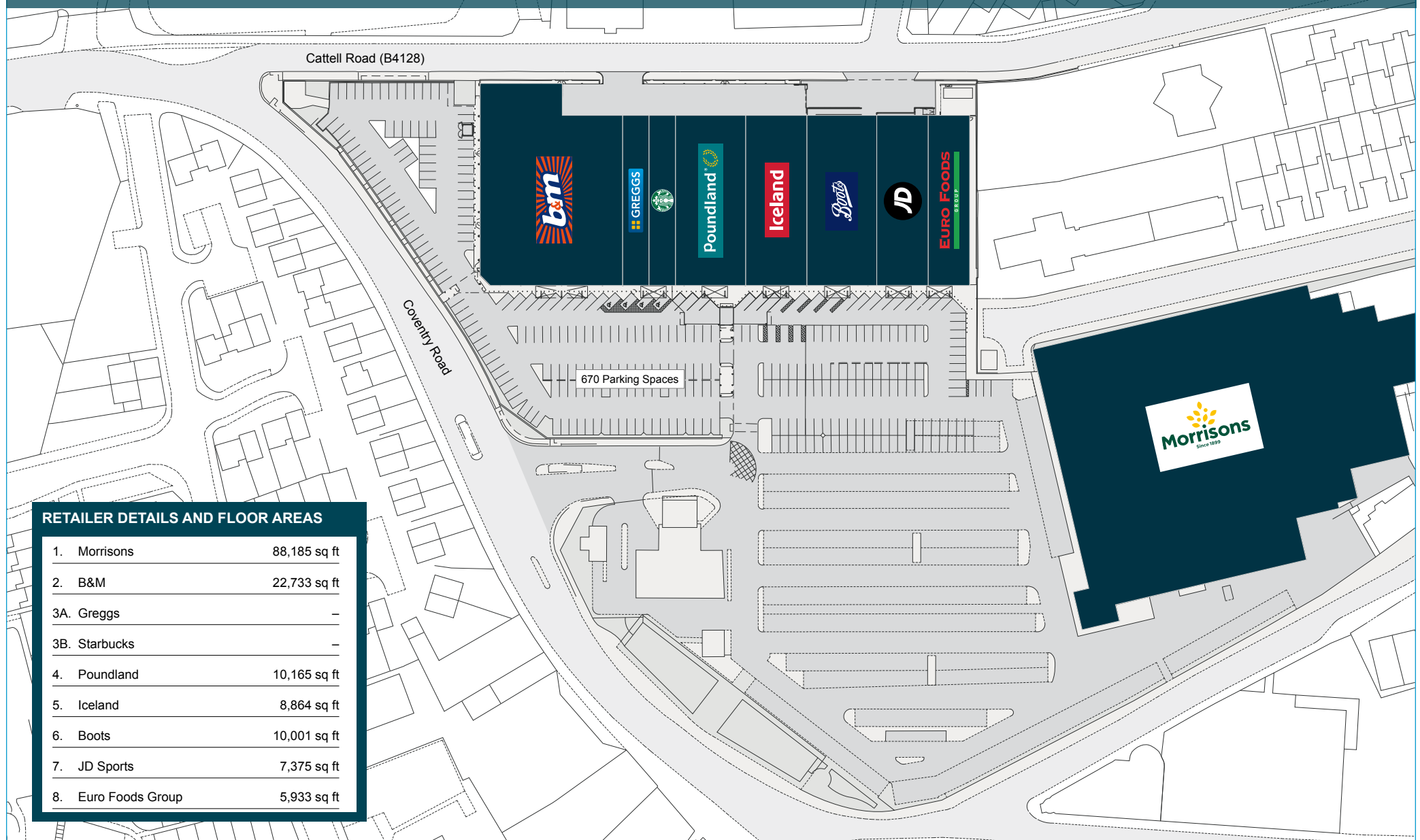
ROAD LOCATION PLAN
